OVER 67% OF OUR CLIENTS IDENTIFY AS BLACK, INDIGENOUS OR PEOPLE OF COLOR, 72% ARE FEMALE AND 19% ARE VICTIMS OF CRIME OR DOMESTIC VIOLENCE; 49% OF CLIENTS ARE DISABLED AND CLOSE TO 36% ARE ELDERLY. OUR CLIENTS ARE AT OR BELOW 200% OF THE FEDERAL POVERTY GUIDELINES (\$55,500 FOR A FAMILY OF FOUR IN 2022). IN 2022, LSHV HANDLED NEARLY 13,000 CASES IMPACTING OVER 30,000 HOUSEHOLD MEMBERS THROUGHOUT THE SEVEN-COUNTY SERVICE AREA.
